Dr. Hughes-Hunter provided an update that OMSD now has its 34th school, SOAR, which is the district's 3rd alternative school of choice.

Martina Ortega asked for clarification on how students are identified and the process. Dr. Hughes-Hunter provided her insight and explained that Dr. James' upcoming programming presentation should provide more information.

Dr. Hughes-Hunter also shared that Preschool programs are now under the SELPA & Equity division, and that collaborative classes staffed with dually credentialed teachers and aides are available at sites such as Mariposa and Kingsley.

Nicole shared that she is a part of the committee that is working on renewing the District's 5-Year Action Plan and emphasized the team's ongoing commitment to serving the community.

Maricela Alvarado shared insights from recent workshops she has attended. She highlighted the importance of communication, especially when students cannot express themselves verbally.

Martina Ortega shared her long history with OMSD, as both a parent and advocate, underscoring the importance of advocacy and community support.

Margarita added that in her five years with OMSD, she has seen the importance of following the chain of command while also standing firm for children's needs.
